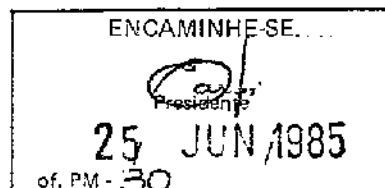

Limpeza e corte de mato no terreno baldio situado entre as ruas Paul Percy Harris e Bela Vista.

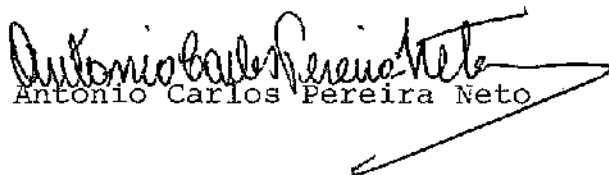
